1. Introduction

2. Our Business

- Review feedback from employees, suppliers, and other stakeholders.

We are committed to continuously improving our practices to combat modern slavery and human trafficking. Our future efforts will focus on:

- Enhancing our risk assessment and due diligence processes.
- Increasing training and awareness initiatives.
- Strengthening our supplier engagement and monitoring activities.
